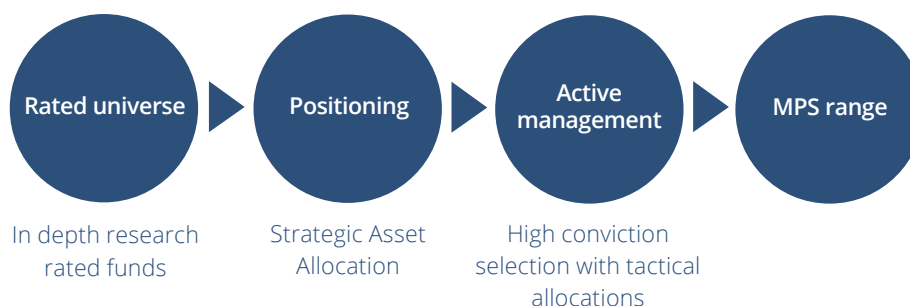

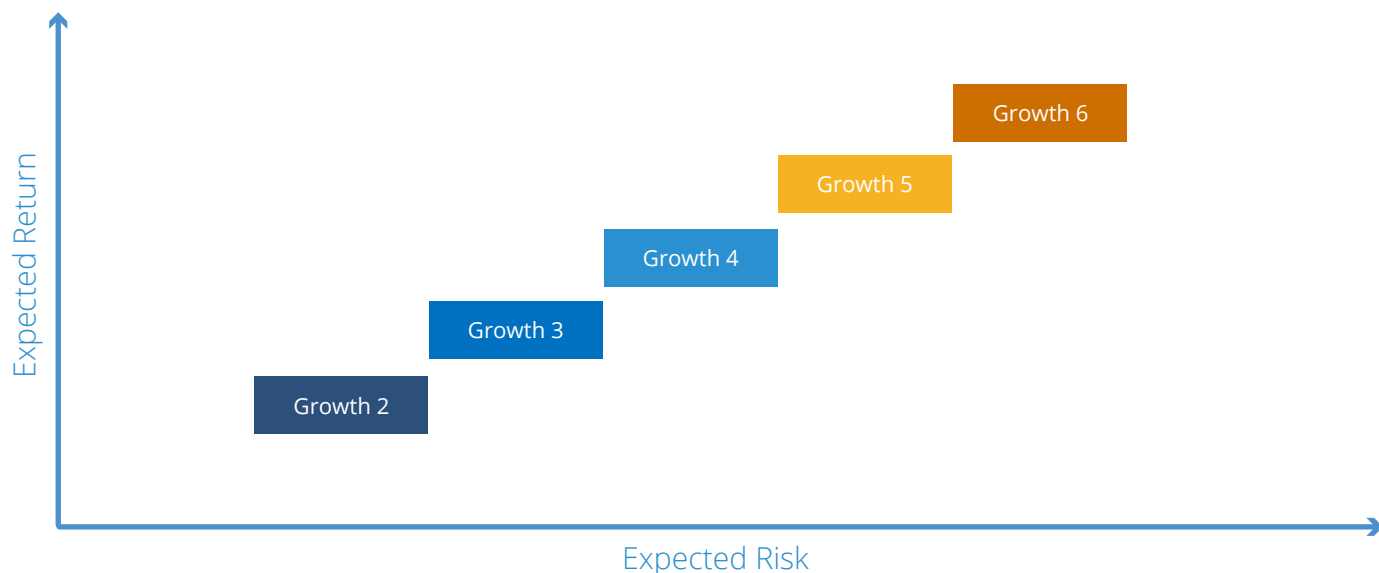

Risk-Mapped And Diversified

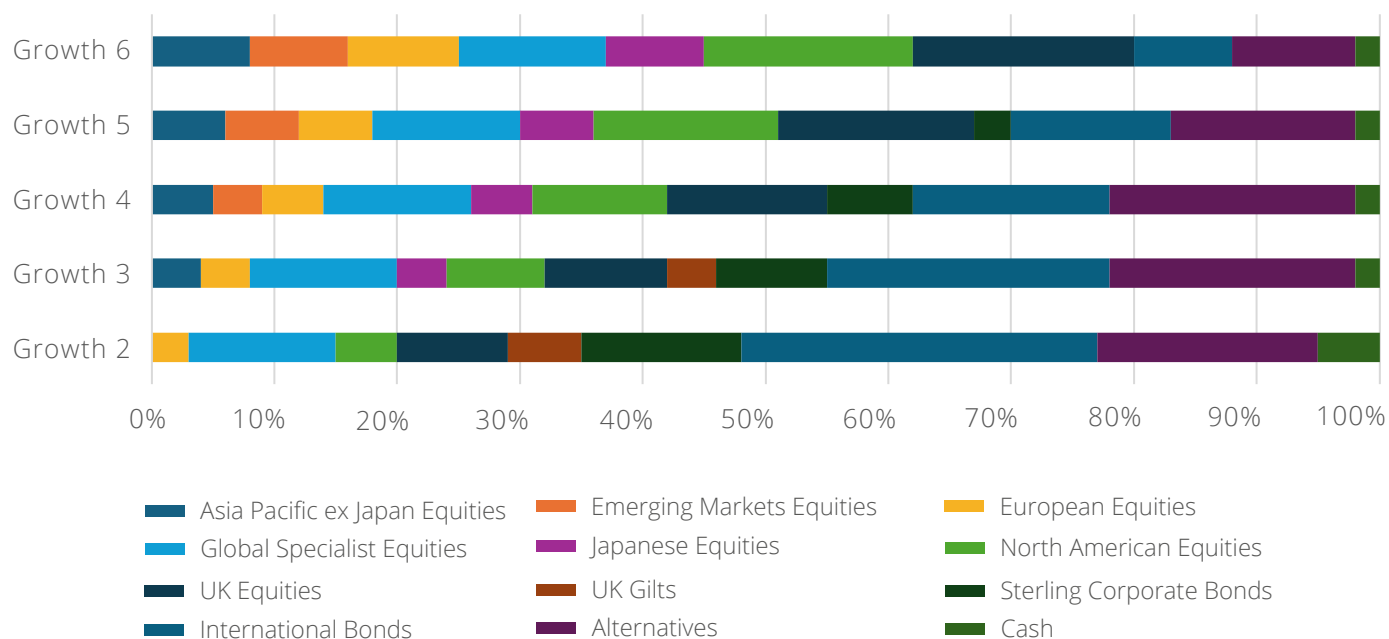
